A MESSAGE FROM THE ONTARIO FIRE MARSHAL AND CHIEF, EMERGENCY MANAGEMENT



We are entering the second year of the transition of our professionalization model, from the Ontario Fire Service Standards to the National Fire Protection Association Professional Qualifications Standards (NFPA Pro Quals Standards), as the basis for our competence-based training practices.

We have successfully completed the transition for our core programs, including the firefighter curriculum, the Fire Prevention Officer Diploma program, the Company Officer Diploma program, and the Training Officer Diploma program. For the second phase of the transition, knowledge and skill requisites in the pertinent NFPA Pro Quals Standards have been incorporated in the specialty courses listed in the calendar such as Pump Operations and Water Rescue. Furthermore, changes to course names have been made to reflect the corresponding NFPA Professional Qualifications Standards.

The Ontario Fire College (OFC) has been and continues to be busy making necessary changes to align its remaining programs with NFPA Pro Quals Standards in preparation for the 2015-2016 academic year at the OFC.

Keeping in mind the changing needs of Ontario's fire service, during the second phase, the OFC has also focused its attention on delivery options. To that end, as explained in the 2015-2016 OFC calendar, challenge exams for Fire Code specific courses have been introduced. Student-learners will be able to take a course challenge exam in order to obtain advance standing and will be able to prepare for the exam at their own pace by using a self-study resource provided by the OFC. Student-learners will be able to take the challenge exams at the OFC and also in regional training centres affiliated with the OFC. Times and dates of the exams, yet to be determined, will be communicated to the fire service at a later date.

In addition, the OFC is introducing "Learning Contracts", whereby fire departments collaborate with OFC instructors to provide training and are able to access OFC curriculum and lesson plans to deliver quality OFC accredited in-house training. Initially, the program will consist of learning contracts for the delivery of NFPA 1001 Level One and Level Two courses. Depending on the success of the program, I hope to extend its application to many other programs, including Fire Officer Level One and Level Two, Fire Instructor Level One and Level Two, and Public Educator programs.

Delivery options of OFC programs will be further expanded with the revamping of the Train-The-Trainer model. Improvements will include trainers being able to issue their own OFC recognized certificates.

I am committed to implementing a delivery model in which the OFC remains an integral part of fire training in Ontario, one that offers state-of-the art training that is affordable and accessible, all without compromising academic excellence.

A MESSAGE FROM ACTING PRINCIPAL GUY DEGAGNÉ

I am proud to present the sophomore edition of the new OFC calendar since its transition to the NFPA Professional Qualifications Standards. We have come a long way since December 2012, when the Fire Marshal and Chief, Emergency Management embarked in revamping the Ontario Fire Service Professionalization Model.

In retrospect, the first year of the NFPA transition has been a resounding success with many courses still showing waiting lists. This success is attributed to the culmination of diligent work by members of the OFC instructional staff, the OFMEM, the advisory committee members, and the support of the Ontario fire service.

Our work is not done! We, at the OFC, are already working hard at completing the second phase of the NFPA transition, where specialty courses will be revamped to meet their respective NFPA Professional Qualifications Standards. In addition, the Public Educator and Fire Inspector programs will see the introduction of higher levels of progression, consistent with their respective standard. We are still committed to academic integrity and to provide excellent programs that will respect the needs of stakeholders.

TAPP-C workshops have been added to complement our Public Educator programs and in an effort to demonstrate the OFC commitment to the first two lines of defense. Youths are often faced with personal challenges and may turn to fire setting as an outlet. This workshop will provide both insight and guidance to professionals that interact with juvenile fire setters and their families to provide solutions in efforts to curtail future occurrences. Public Education is the cornerstone of any public safety program. The OFC is releasing a Public Educator II program and will endeavor to pilot Public Educator III during the 2015-2016 calendar.

Municipalities and Fire Services are consistently measuring their abilities to provide protective services to match their community needs. The OFC recognizes the need to provide specialized training that will allow municipalities to offer the enhanced level of protection. With this, we are introducing Ice Rescue, both Level I and II along with Surface Water Level I and II; both to the NFPA 1006 standard as well as Pumps Ops to NFPA 1002 standard.

Furthermore, understanding geographical disparity within the Province of Ontario, the Ontario Fire College has identified the need to deliver a program that is specific to unique challenges of rural firefighting. To this end, the OFC is developing a “Rural Firefighting” program based on Coletti’s *No Non-Sense Guide to Small Community Fire Protection*. This new rural firefighting program will equip rural fire departments with the skills and knowledge to respond to fire incidents allowing fire suppression tactics to be more efficient. The OFC will be working in collaboration with OFMEM – Academic Standards and Evaluation to have the program accredited as an alternative standard through IFSAC.

The Ontario Fire College has made great strides in the past year to enhance opportunity for learning and development. Recently the Ontario Fire College has undertaken facility modernization projects to improve the accessibility to internet services. As such, the OFC has now full WI-FI accessibility, which will allow students seamless access to digital resources, while we continue to support our *Green* initiatives at the OFC. We encourage students to leverage digital access to course materials and resources as part of educational experience.

We will continue our endeavours to make our programs easily accessible through on-line learning and expanding capacity to deliver OFC courses through Regional Training Centres throughout the Province. The OFC remains steadfast in its pledge to develop and deliver Programs that are Accessible, Affordable, and Attainable.

HOW TO REGISTER FOR COURSES AT THE ONTARIO FIRE COLLEGE

E-applications are processed in the order that they arrive in the Registrar's Office and, in order to increase your chances of being accepted on courses, e-applications should be sent to us as soon as possible.

Once courses have filled we begin to accept student-learners onto wait lists. If cancellations come in throughout the year the fire chief (or his/her designate) of the next candidate on the wait list will be notified immediately. Please note that our courses fill up very quickly and have significant wait lists and you are encouraged to apply for these courses as quickly as possible.

Applications can be sent beginning **Monday, December 1, 2014 at 8:00 am** in the following manner:

1. Using the electronic application form located on the Ontario Fire College website www.ofmsps.ca/OFCEM.
Username: ofc Password: preclass Scroll down and enter the link "College Calendar" to find the E-Application form.

We encourage you to apply for courses using the electronic application form only.

2. Scan and e-mail: The application form is located on the OFC Website www.ofmsps.ca/OFCEM.
Username: ofc Password: preclass. Scroll down and enter the link "College Calendar" to find the E-Application form. Print and scan the application (signed by F/Chief or designate) and send by e-mail to applyofc@ontario.ca.
Applications without the signature of the Fire Chief or his/her designate will be rejected.

Should you choose to scan and email please include no more than ten applications per attachment.

3. Applications submitted electronically or by email preferred. *If you have no other alternative* fax to 705-687-4611

Please note that we no longer accept hand-delivered applications.

MAXIMUM NUMBER OF APPLICATIONS APPROVED PER COURSE - PER FIRE DEPARTMENT

In order to accommodate as many fire departments as possible on each course, a maximum of two (2) applications per fire department will be accepted.

HOW TO IMPROVE YOUR FIRE DEPARTMENT PERSONNEL'S CHANCES OF BEING ACCEPTED ON COURSES:

- Fill out E-application form completely showing course numbers and start date
- If you are scanning the application form to submit by email please print legibly
- Make certain the application is approved by the Fire Chief or designate
- Complete a separate e-application form for each participant for each course
- When applying for a series of courses where prerequisites apply, the participant must be accepted on the prerequisite course before he/she can be accepted on the remaining courses. In other words, if the course you applied for is full and your name is placed on the wait list, your e-application for the following course will be rejected and you must re-apply.
- If there is documentation required (i.e. copies of licences, certificates, etc.) ensure that the Fire Chief or his/her designate has attested to the fact that the registrant has the required documentation by signing the e-application form. Random audits will be done throughout the year to ensure that documentation is available at the fire department.

VACANCIES

Vacancy applications will no longer be accepted for courses or workshops. Applicant names are required, no spaces will be held.

CANCELLATION POLICY

- The Fire Chief (or his/her designate) should notify the Registrar's Office in writing by e-mail at applyofc@ontario.ca as soon as you realize that your candidate will not be able to attend. **We do not accept verbal cancellations.**
- If you wish to send a substitute student-learner, submit an e-application form with a note regarding the replacement before

he/she attends the college. Please ensure that any substitute student-learner has successfully completed the prerequisite course (if required) and has been given adequate time to complete pre-class material.

- For cancellations received less than eight weeks prior to the start date of the course or workshop, the Registration Fee will still apply and be invoiced to the Fire Department.

WHO WE ARE

The Office of the Fire Marshal and Emergency Management (OFMEM) is a branch of the Ministry of Community Safety and Correctional Services.

MISSION

The mission of the OFMEM is to contribute to an environment for the residents of Ontario that is safe from fire and other public safety hazards by providing leadership and expertise in the reduction and elimination of these hazards.

ROLE

The role of the OFMEM is to minimize the loss of life and property from fire in Ontario by providing

- support to municipalities and fire departments across Ontario in meeting the needs of their communities, including public education, fire prevention, firefighting, fire protection, training, and fire investigation,
- leadership within the Ontario Government by advising on standards and legislation relating to fire prevention and protection, and
- Recommendations for the provision of adequate levels of fire safety for buildings and premises within Ontario.

ORGANIZATIONAL STRUCTURE

The Fire Marshal of Ontario is appointed by the Lieutenant Governor-in-Council. The Fire Marshal acts as the principal advisor to Government on public fire protection policy and fire safety issues. In addition to administering the overall operation of the OFMEM and fire-related legislation, the Fire Marshal provides leadership to municipalities and municipal fire services in matters relating to public fire safety.

The OFMEM operates from a head office, in Toronto, as well as from offices in Midhurst, Sudbury, Thunder Bay and the Ontario Fire College in Gravenhurst.

ONTARIO FIRE COLLEGE

In operation since 1949, the Ontario Fire College's primary mandate is to meet the education and training needs of the Ontario fire service. As of April 2014, the Ontario Fire College will offer education and training programs based mostly on the National Fire Protection Association – Professional Qualifications Standards.

ONTARIO FIRE COLLEGE ADVISORY COMMITTEES

The Ontario Fire College holds regular meetings with its Program Advisory Committees. All of the committees provide ongoing advice and recommendations to the College on all aspects of its programs and courses.

LEGISLATION

This course offers student-learners an overview of the various laws, regulations and standards that impact the delivery of fire protection in Ontario. The NFPA Professional Qualification Standards and Section 21 Guidance Notes are discussed, along with the Fire Protection and Prevention Act, Occupational Health and Safety Act, and other legislation that affects day-to-day fire service operations. This course is offered online and regionally throughout the province. **This course is a co requisite (required prior to seeking certification for all NFPA Programs). Fire fighters that have successfully completed the former CO/FPO 101, Legislation Orientation course already meet the requirement.** There is no restriction on the number of student-learners per Fire Department that can register for this course. Once a student-learner is registered and approved for a Legislation course they must complete the course or they will be issued a failing grade.

Prerequisite: None.

Once a student-learner commences the course they must complete the course in the required time frame or they will be issued a failing grade.

In-Class Session: None

Alternate delivery: Self-Directed online through OFC

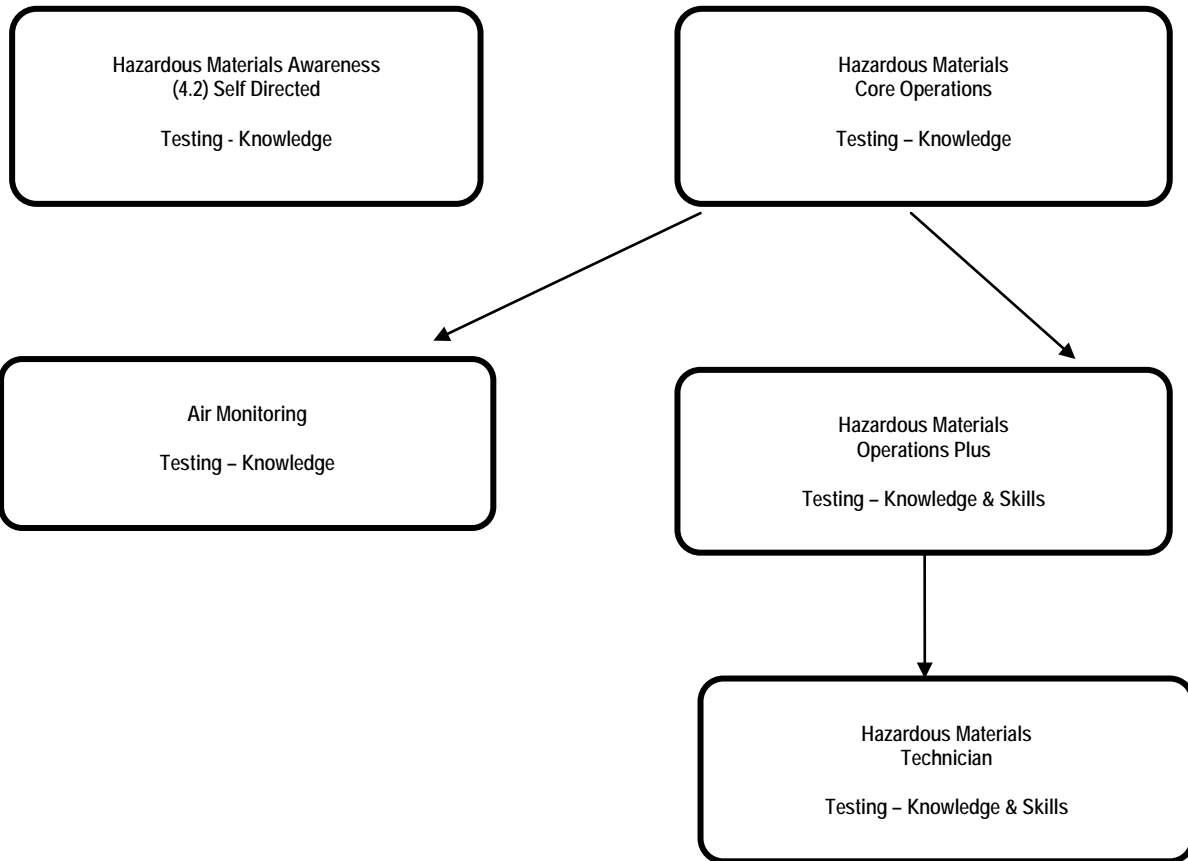

NFPA 472 – Hazardous Materials Awareness (4.2)

The student-learner will be able to identify the name, UN/NA identification number, type of placard or other distinctive marking applied for the hazardous materials/WMD involved, collect information from the current edition of the Emergency Response Guidebook (ERG), identify container shapes that can indicate the presence of hazardous materials/WMD, identify the basic information on material safety data sheets (MSDS) and shipping papers for hazardous materials. **There is no restriction on the number of student-learners per Fire Department that can register for this course.**

NFPA 472 Hazardous Materials Core Ops

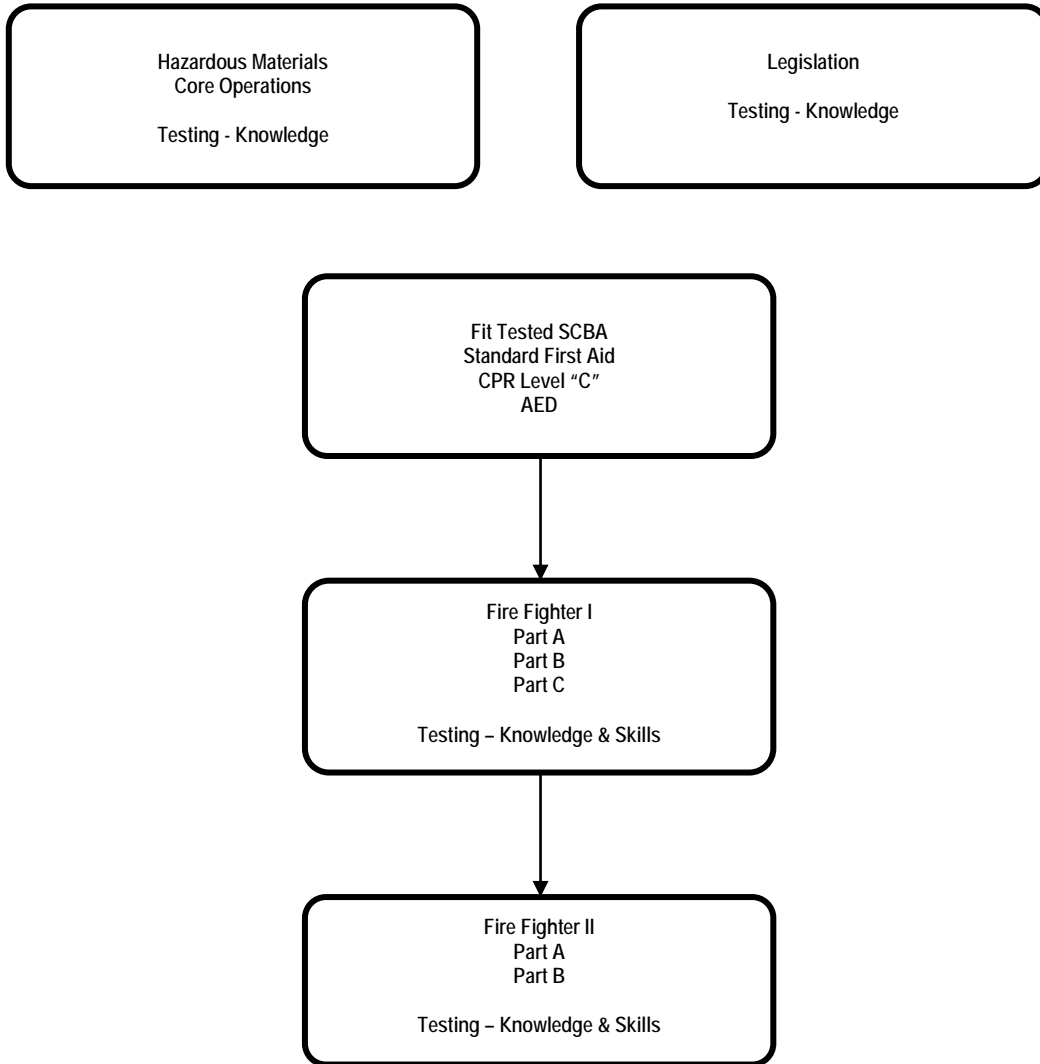

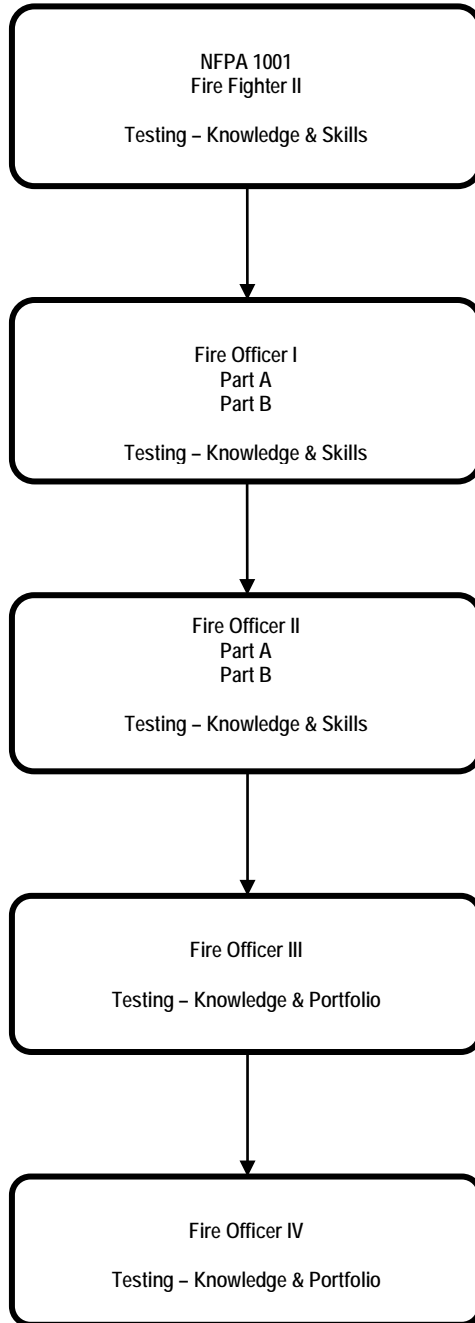

SOLAR PHOTOVOLTAIC SYSTEMS, WIND TURBINES & FIREFIGHTER SAFETY

NFPA 1006 ICE RESCUE LEVEL I

NFPA 1006 SURFACE WATER RESCUE LEVEL I

This course focuses on the knowledge and skills required to perform Surface Water Rescue. The student will understand and demonstrate the characteristics and hazards associated with working around surface water, self-rescue techniques, rescuer safety, victim rescue, size up, preplanning and the requirements to support Surface Water Rescue Level II operations.

This course is physically demanding and participants should be in good physical condition. Upon commencement of the course, student-learners must be able to swim 100 meters wearing a Personal Flotation Device, swim 100 meters without a Personal Flotation Device and complete a tread water test of 15 minutes without Personal Flotation Device.

Prerequisite: NFPA 1006 Technical Rescuer Core (CHAPTER 5) and Standard First Aid and CPR Level “C”.

In-Class Session: 3 days

Cost: Fire departments will be charged a non-refundable registration fee of \$65.00 for each student-learner accepted into this course. The registration fee is not charged for cancellations received a minimum of eight weeks prior to the course start date. Fire departments will be sent an invoice on a quarterly basis.

NFPA 1006 SURFACE WATER RESCUE LEVEL II

This course is designed to provide the knowledge and skills required to perform Surface Water Rescue Level II operations. The student will understand and demonstrate how to assign resources, perform entry rescue using various rescue devices while working within the Incident Command System.

This course is physically demanding and participants should be in good physical condition. Upon commencement of the course, student-learners must be able to swim 100 meters wearing a Personal Flotation Device, swim 100 meters without a Personal Flotation Device and complete a tread water test of 15 minutes without Personal Flotation Device.

Prerequisite: NFPA 1006 Technical Rescuer Core (CHAPTER 5) and NFPA 1006 Surface Water Rescue Level I and Standard First Aid and CPR Level "C". * **Note:** the Water Rescue or Water/Ice Rescue course previously offered by the OFC does not meet the prerequisite requirement for this course.

NFPA 1006 TECHNICAL RESCUER CORE

This course will cover the job performance requirements that shall be met under the NFPA 1006 Chapter 5 – 2013 edition prior to being qualified as a Technical Rescuer. The course includes a comprehensive understanding of site operations giving a specific type of rescue incident. In addition, this course provides an overview of victim management including triage and assessments of rescue vs. recovery. It provides an in depth understanding regarding inspection and maintenance of rescue equipment. Finally, the course will teach how to tie knots, bends, and hitches so that the knots are recognizable.

Prerequisite: NFPA 472 Hazardous Materials Awareness and Standard First Aid and CPR Level "C".

CN RAILWAY - Railroad Emergency Response Management

This course, which is offered in conjunction with CN Railway, is intended for chiefs and senior officers likely to be involved in incident management of rail incidents and will build upon participants' knowledge of the Incident Management System. Participants will learn about the roles individual employees and departments play at a rail incident and CN's internal incident command structure, as well as the protocol for functioning in a unified incident command system if multiple stakeholders are involved. The seminar participants will review the CN Emergency Response Plan, and participate in a tabletop exercise using the plan and their newly acquired knowledge of railroad emergency response management.

Prerequisite: Intended for Chiefs and senior officers likely to be involved in the incident management of rail incidents.

In-Class Session: 2 days

Cost: Fire departments will be charged a total non-refundable registration fee of \$240.00 for each student-learner accepted into this course. CP RAIL – CRUDE & ETHANOL FIRE FIGHTING FOR RAIL

This course, which is offered in conjunction with Canadian Pacific Railway, is intended for fire fighters who are employed in Fire Departments in communities with Class One Railways that are likely to be involved in rail incidents. The course will build upon participants' knowledge of chemical response and industrial firefighting. Participants will learn about the differences between sweet and sour crude oil, firefighting tactics with tank cars and health concerns of crude oil. The course participants will learn how to effectively use AR - AFFF on rail cars, how to cool cars, set up and railway operations. Full Turnout Gear including safety goggles and 2 pairs of safety gloves are required for the course. SCBA not required.

Prerequisite: Intended for fire fighters who are employed in Fire Departments in communities with Class One Railways that are likely to be involved in rail incidents. Hazardous Materials training and experience would be an asset.

Cost: Fire departments will be charged a total non-refundable registration fee of \$240.00 for each student-learner accepted into this course.
